### <mark>01.02.2015</mark>

The meeting holds at People's Participation office today at 2pm to 4 pm on some official issues. It has been discussed that we will apply to different Govt grants to work more strongly. And we will engage with Children-Aged people- Women and environment issues to change the society and the larger environment. It is also decided that from now PP would disbursed its Human Rights Identity Card after a thoroughly checked the volunteer's behaviour.

#### 03.03.2015

The meeting holds at People's Participation office today a 4pm to 6 pm on some official issues. It has been decided that we will go through devnetjobsindia.org to post in free for volunteers as the number of volunteers' are decreased every day. And a leafter viil be prepared to paste in different important public places and local trains to attract volunteers

Some memorandums and RTI will be deputed to different Govt organs as W.B Human Rights Commission, W.B Irrigation Deptt, Howrah D.R.M and others.

RTI camps will be organized by our voluctee:s at Sealdah, Dankuni, Barrackpore and Khardah at present and if required then other places too.

#### 05.04.2015

The meeting holds at People's Participation office today at 3pm to 5 pm on some official issues. In the meeting we discussed some important issues as to build a women Rights wing, Grant application to different Govt organs, volunteers and accounts for coming 2014-15 audit. It has been decided that we will search a new auditor to audit for the upcoming FY as the previous one do wrong audit and do not maintain schedule time. ICF from SUDA asked to audit their previous grants and we have to invite them with all relevant documents in this month.

#### 01.05.2015

The meeting holds at People's Participation office today at 11am to 2 pm on some official issues. It has been decided that we will be more responsible on Children and so PP will maintain a 'Child Protection Policy' of its own and prepare a 'Child Protection Policy' (CPP) in writing and Notary by Court. Today we

have celebrated 'May Day' by delivering speech in open street and distributed 1000 leaflets to motivate working people to understand their rights.

#### <mark>02.06.2015</mark>

The meeting holds at People's Participation office today at 1pm to 3 pm on some official issues. PP will support to form a 'Trust' through registration by an agent to work in coming future. Trust will work on school issue and Ashram issue. It has decided that PP will give advertisement in local newspaper on free land issue on donation basis to build an 'Ashram'.

A project has been approved by 'Central Institute of Indian Languages', to conduct a '**State Level Seminar on Spreading Bengali Language'.** 

#### 06.07.2015

The meeting holds at People's Participation office today at 2pm to 4 pm on some official issues.

We applied to ActionAid Association for grant on Children Issue and they asked us to do a survey on child labour issue at Titagarh to Barrackpore and Bhatpara Brick Killins on that issue and submit a report soon.

Our website developer '**Microtel InfoTech'** has been stordown suddenly and new posting in website is failed; so we are searching a new well established vebsite developer with a reasonable rate so far.

## <mark>03.08.2015</mark>

The meeting holds at People's Participation office today at 2pm to 4 pm on some official issues. We plan to apply to Netaji Subhas Open University' to engage with its network partner to provide different courses to irregular students from Dankuni center to cover the Hooghly District so far. So we will apply to NSOU soon with all official documents.

We have prepared a '**Purchase Committee'** (Notary) for People's Participation for maintaining the internal accounts system more strongly as it instructed by ActionAid Association.

Four Consumer Cases has been filed in District Consumer Forum by those victims through our 'Consumer Protection Cell' wing in free of cost.

We have submitted a 'Library Awareness Project' on Seminar Grant to RRRLF through District library Office.

## 05.09.2015

The meeting holds at People's Participation office today at 11am to 1 pm on some official issues. PP will apply to engage with TISS through its Registration system to be a CSR Grant Partner. We also to prepare documents to submit to renew PP's FCRA registration certificate this year and within October end-2015 without miss.

We also Surrender SWABALAMWAN proposal which was sanctioned this month to work for women domestic help by engaging SDO-BDO- DSW through training. We have very bad experiences to work with those Govt Deptt previously and we send surrender letter to 'Women Undertaking' Deptt by clarification the obstructions to run the programme.

We have received Rs 4 Lakh from ActionAid Association; Kolkata R.O to work against Child Labour issue at North 24 Pgs be engaged with different Govt Deptt.s. Interview to select staff for the programme has been completed and all four staffs selected from IGNOU MSW Deptt. We have stared the programme in time in field.

New audit farm recruited and they done the People's Participation audit in time and also fulfilled the previous year 'audit terms and conditions' as instructed by the Income Tax Deptt.

## 02.10.2015

The meeting holds at People's Participation office today at 2pm to 4 pm on some official issues. Central Govt and State Govt are planning to withdraw Pass- Fail concept from Primary school through amendment the 'Right to Education' Acts. PP is opposing the amendment and start campaigning against the Govt concept. So we will depute some memorandums to State Education Minister, Prime Minister and others and will prepare some leaflets in Bengali version to distribute among the general people.

We have submitted all required documents to 'Minist' ( or flome Affairs' to renew the FCRA Registration.

We have terminated 3 staffs engaged with 'Child Labour project' out of four as their success rates was very low and not motivated to work for the cause and new people (all female) elected through interview process to continue the work.

RTI reply came from W.B Human Kights Commission against our RTI application on September-2015.

A wing on 'Women Rights' will be established within short period of time in Chanditala Block by a lady volunteer; she need some training in this regard.

The meeting holds at People's Participation office today at 5pm to 7 pm on some official issues. After December-2015 People's Participation is planning to file a court case against irrigation Deptt to Green Bench' on Saraswati River issue. And filing RTI/or Memorandum to CM along with all documents on Electric Chulli issue.
